#### **Blackall-Tambo receives Reconciliation Week funding: Maranoa MP**

SUPPORTED by an unprecedented 90% of voters 50 years ago, a referendum to recognise Indigenous people in the Census and give the Federal Government powers to create equitable laws will be remembered this week along with 25th anniversary of the Mabo High Court decision.

To support our community to remember and celebrate these events, Federal Member for Maranoa David Littleproud said he was pleased to announce a \$5000 grant to help the Blackall-Tambo Council with National Reconciliation Week events.

“Reconciliation Week runs from May 27 to June 3 and I’m delighted the Blackall-Tambo Council is able to mark the significance of these two occasions, recognising the importance of these events,” Mr Littleproud said.

“The council will partner with the Central West Aboriginal Corporation to remember and celebrate these two significant events in our nation’s history.

“This week we not only remember and celebrate the 50th anniversary of the 1967 referendum but also the 25th anniversary of the Mabo High Court decision as part of National Reconciliation Week activities.

“In Australia, a referendum is a vote used to approve a change to the Australian Constitution and, in 1967, this referendum achieved a 90.77% ‘yes’ vote to recognise Indigenous people.

“The Mabo High Court case was a landmark moment in the history of Indigenous land rights, overturning the doctrine of ‘terra nullius’ that led to the passing of the *Native Title Act 1993*.”
